I am to submit that the A.M.A.L. College is one of the oldest colleges established in the year 1953 and it has been maintaining very good academic record right from the inception. The Institution has been maintained by the Anakapalle Merchant's Association for the welfare of the poorest of the poor without taking any profit, caste and creed. It has also recognized under 2(f) 12(b) of U.G.C. 1956 Act. The college got accredited by NAAC with B⁺⁺ on 10-02-2007. The First cycle was completed on 10-02-2012.

Due to some following reasons, we could not attend the next subsequent cycles. After 2012, many senior teaching faculties were retired and apart from that the college was disturbed by Covid from March 2020 to 2021.

During the year 2021, our college Management initiated the Staff to go for NAAC. In this situation the Government has issued the G.O. for the absorption of the Aided colleges into Government Colleges. In this regard, our college Aided staff were fully diverted. After that, Government also permitted us to run the college as Aided College.

Now, the Management strongly resolved in the Governing Body to go for NAAC 2nd cycle. In this regard, we have recently registered our college (C-24436) in the NAAC website on 09-02-2023.

Actually we have to submit the AQARs for last five years but we have not submitted the AQARs till now.


Hence, we humbly request you to allow us and give your kind permission to submit the AQARs by the month of October 2023.
